Dear fellow members,

It's with a great sense of responsibility and humility that I put forward my candidature for re-election for the post of President of the SCC.

We have had a good year in 2018, the Club achieved a net profit after tax of S\$ 218,000, we had increased F&B revenue of S\$ 9.6 million, with increased covers over last year, and over all we increased our revenue to S \$19.6 million and increase of S \$ 123K over the previous year. We also added S\$1.6 million to our sinking fund for the renewal of the Padang.

This term saw

- Two new GC portfolio -were created Special Projects (implementation/Legal), and Special Projects (Social) to increase intra-Club participation and engagement between our more sporting-focused Members and our more social members
- Renovations to the kitchen, Main lounge and the Padang restaurant. Leading to increased revenue and better member experience.
- We also launched new dining and social events like the Wine Gourmet dinner and new oval menu and "changed" old events like New Year's party.
- We amplified our communication channels to generate more publicity for the F&B, social and sports events and activities. We started a club Face Book page.
- We had an Increase in our sports and junior membership
- The club organized several international tournaments, all hugely successful and profitable.
- We also reassessed our organizational structure with a view to optimizing our staff resources. Staff training and upskilling were continuous to ensure quality performance and high service standards.

Going forward we will be creative and bold. We will try not only to do different things, but do things differently. With the changing face of Singapore, we will add new and innovative measures to ensure we stay relevant and provide an enhanced membership experience and ensure financial stability of the club, we would further build up on our most value able asset the SCC brand name. This entails strengthening our sporting and social culture.

We will look to revamp and improve our F&B offerings, including purchasing and cost control. F&B accounts for 48% of our budget and I feel this is an area we can still make marked improvements.

We shall continue to strengthen management to ensure the club can be run consistently and professionally. I believe my experience in running my own company should come in handy here. I would also work hand in hand with all the GC members to provide them all the support and constructive ideas

Above all I shall always strive to be a good club man.



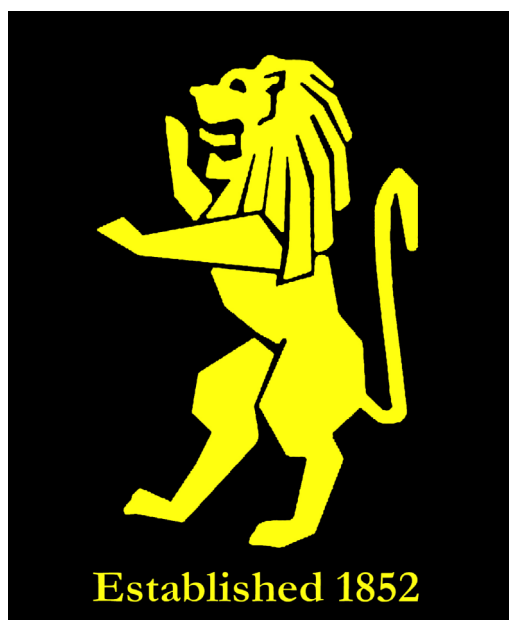
